RESOLUTION NO. 163-2019

DECLARING ORDINANCE NO. 2018-20 OF THE SANGGUNIANG PANLUNGSOD OF ALAMINOS, PANGASINAN, ENTITLED "AN ORDINANCE RATIFYING THE TERMS AND CONDITION STIPULATED IN THE LEASE AGREEMENT BETWEEN THE CITY GOVERNMENT OF ALAMINOS AND LKY RESORTS AND HOTELS, INC. FOR THE LEASE OF PARCELS OF LOT SITUATED AT BRGY. LUCAP, THIS CITY, REGISTERED IN THE NAME OF THE CITY GOVERNMENT OF ALAMINOS, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG PANLUNGSOD TO ENACT

WHEREAS, the Sangguniang Panlungsod of Alaminos, Pangasinan submitted its Ordinance No. 2018-20 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Sections 22 (5) (c); 296 (a) (b); 297 (a) (b) (c); 455 (1) (vi) and 458 (a) (2) (iii) and (iv) of RA 7160;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject ordinance in order;
