## **RESOLUTION NO. 164-2021**

APPROVING RESOLUTION NO. 288, S-2020 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED "APPROVING THE MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NUMBER 9 WITH THE CY 2020 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NUMBER 8 OF THE MUNICIPALITY OF ASINGAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Resolution No. 288, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Asingan, Pangasinan has formulated the municipality's Supplemental Annual Investment Program No. 8 covering projects to be funded from LGU's share from the FY 2017 Collection of Burley and Native Tobacco Excise Tax in the amount of P3,106,897.00. This was endorsed thru MDC Resolution No. 9, dated December 10, 2020 and approved by the Sangguniang Bayan thru Resolution No. 288, S-2020 dated December 14, 2020;

**WHEREAS,** the projects identified to be funded by Excise Tax conforms with Local Budget Memorandum No. 81 dated November 4, 2020 (Guidelines on the Release and Utilization of the Shares of Local Government Units from the FY 2017 Collections of Excise Tax on Locally Manufactured Virginia-Typed Cigarettes under RA No. 7171 and Burley and Native Tobacco Excise Tax Pursuant to RA 8240, as amended by RA 10351, chargeable against the Allocation of Local Government Units under the FY 2019 General Appropriations Act, RA 11260);
