**RESOLUTION NO. 165-2021**

**APPROVING RESOLUTION NO. 289, S-2020 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED “APPROVING THE MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NUMBER 10 WITH THE CY 2020 SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NUMBER 9 OF THE MUNICIPALITY OF ASINGAN, PANGASINAN”**

**WHEREAS**, the Sangguniang Bayan of Asingan, Pangasinan submitted its Resolution No. 289, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Asingan, Pangasinan has formulated the municipality’s Supplemental Annual Investment Program No. 9 and endorsed thru MDC Resolution No. 10, S-2020 dated December 22, 2020 to the Sangguniang Bayan for approval;

**WHEREAS**, the Supplemental Annual Investment Program No. 9 with an investment requirement of P1,281,000.00 covers the provision of Service Recognition Incentive benefits for municipal officials and employees;

**WHEREAS**, the Sangguniang Bayan on December 23, 2020 enacted Supplemental Budget No. 7 thru Appropriation Ordinance No. 9, S-2020 to support the implementation of the Supplemental Annual Investment Program of the municipality;
