APPROVING RESOLUTION NO. 58, S-2021 OF THE SANGGUNANG BAYAN OF MAPANDAN, PANGASINAN, ENTITLED “APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PLAN (AIP) NO. 5, SERIES OF 2021 OF THE MUNICIPALITY OF MAPANDAN, PROVINCE OF PANGASINAN AMOUNTING TO FOUR MILLION EIGHT HUNDRED ELEVEN THOUSAND FIVE HUNDRED NINE PESOS AND SIXTY CENTAVOS (P4,811,509.60) WHICH WILL COME FROM THE SAVINGS OF GENERAL FUND AND OPERATION OF ECONOMIC ENTERPRISE FOR THE FOLLOWING PURPOSES: I. APPROPRIATION FOR THE GRANTS OF OTHER PERSONNEL BENEFITS/SRI; II. AUGMENTATION FOR MAINTENANCE AND OTHER OPERATING EXPENDITURES; III. AUGMENTATION OF CAPITAL OUTLAY; IV. ADDITIONAL 5% LDRRM FUND; AND V. AUGMENTATION FOR OTHER SPECIAL PURPOSE APPROPRIATIONS”

WHEREAS, the Sangguniang Bayan of Mapandan, Pangasinan submitted its Resolution No. 58, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Municipal Development Council of Mapandan, Pangasinan prepared the municipality’s Supplemental Annual Investment Plan No. 5, CY 2021. This was endorsed by the Council, through MDC Resolution No. 06, Series of 2021 dated November 24, 2021, to the Sangguniang Bayan for approval;

WHEREAS, said Supplemental Annual Investment Program, which has a total investment requirement of P4,811,509.60, covers augmentation funds for Personal Services, Maintenance and other Operating Expenses (MOOE) and Capital Outlay of the LGU to include the granting of Service Recognition Incentive and the implementation of DRRM projects and other development undertakings of the LGU;

WHEREAS, funding support for the Supplemental AIP will be sourced from the General Fund and Operation of Economic Enterprise of the LGU as embodied in their Supplemental Budget No. 5, CY 2021, and enacted by their Sangguniang Bayan through Appropriation Ordinance No. 6, Series of 2021 dated November 29, 2021;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all the existing laws, rules and regulations shall be the responsibility of the Municipal Government of Mapandan, Pangasinan;

WHEREFORE, in view of the foregoing, on motion of SP Members Vici M. Ventanilla and Angel M. Baniqued, Jr. and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was—

RESOLVED, by the Sangguniang Panlalawigan in session assembled, to approve Resolution No. 58, S-2021 of the Sangguniang Bayan of Mapandan, Pangasinan, entitled “Approving Supplemental Annual Investment Plan (AIP) No. 5, Series of 2021 of the Municipality of Mapandan, Province of Pangasinan amounting to Four Million Eight Hundred Eleven Thousand Five Hundred Nine Pesos and Sixty Centavos (P4,811,509.60) which will come from the savings of General Fund and Operation of Economic Enterprise for the following purposes: I. Appropriation for the Grants of Other Personnel Benefits/SRI; II. Augmentation for Maintenance and Other Operating Expenditures; III. Augmentation of Capital Outlay; IV. Additional 5% LDRRM Fund; and V. Augmentation for Other Special Purpose Appropriations”;
