**RESOLUTION NO. 173-2020**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 3 FOR CALENDAR YEAR 2019 OF SAN FABIAN, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P3,387,238.84 OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2019 involving total appropriations of **P3,387,238.84** which was approved on December 4, 2019 through Appropriation Ordinance No. 4, S-2019;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. The grant of One-Time Service Recognition Incentive for FY 2019 for municipal officials and employees shall be in accordance with the provisions of Budget Circular No. 2019-6 dated December 9, 2019 of the Department of Budget and Management;
2. All programs, projects and activities shall be in accordance with the approved Local Development Plan and FY 2020 Supplemental Investment Program of the municipality formulated pursuant to DILG-NEDA-DBM Joint Memorandum Circular No. 1, S-2007 dated 08 March 2007; and

3. The funding sources for the subject Supplemental Budget were determined in accordance with Section 321 of RA 7160 and Article 417 (a) of its IRR, as amended by Administrative Order No. 47 dated April 12, 1993.


