DECLARING MUNICIPAL ORDINANCE NO. 01, S-2020 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED "AN ORDINANCE CREATING A SPECIAL ACCOUNT IN THE GENERAL FUND (SAGF) FOR THE BAYANIHAN GRANT TO CITIES AND MUNICIPALITIES (BGCM) IN THE MUNICIPALITY OF BANI, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its Municipal Ordinance No. 01, Series of 2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, Local Finance Committee and the Provincial Planning and Development Authority, have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Section 313 (c) of RA 7160; DBM Local Budget Circular No. 125 dated April 7, 2020 (Guidelines on the Release and Utilization of the Bayanihan Grant to Cities and Municipalities);

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject municipal ordinance in order;
