RESOLUTION NO. 174-2021

APPROVING RESOLUTION NO. 122-2020 OF THE SANGGUNIANG BAYAN OF BURGOS, PANGASINAN, ENTITLED “APPROVING THE ANNUAL INVESTMENT PROGRAM FOR CALENDAR YEAR 2021 OF THE MUNICIPALITY OF BURGOS, PROVINCE OF PANGASINAN”

WHEREAS, the Sangguniang Bayan of Burgos, Pangasinan submitted its Resolution No. 122-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Burgos, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for Calendar Year 2021. This was endorsed by the Local Development Council to the Sangguniang Bayan on August 19, 2020 through MDC Resolution No. 2020-006;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Burgos, Pangasinan was formulated following the prescribed AIP Summary Form, and covers: a) all the regular budgetary requirements for the operations of the different city offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority

development programs/projects of the LGU including those to be funded by the 20% development fund, c) Disaster Risk Reduction Management Plan, d) Local Climate Change Action Plan, e) Peace and Order Plan, f) Gender and Development Plan, g) Culture and Arts Development Plan, h) Nutrition Plan, and i) Programs/Projects/Activities (PPAs) for the Local Council for the Protection of Children, Senior Citizens and Persons with Disabilities, PPAs to combat AIDS and PPAs to address the problems of illegal drugs;

WHEREAS, the proposed AIP of Burgos for CY 2021 has an investment requirement of P756,235,000.00. Funding support for the implementation of which is embodied in their 2021 proposed Annual Budget in the amount of P119,735,000.00, which was passed and approved by their Sangguniang Bayan on December 1, 2020 through Appropriation Ordinance No. 06, S-2020 and approved by the Municipal Mayor on December 7, 2020. The remaining P636,500,000.00 is proposed for funding from external sources/national government agencies (P634,500,000.00) and from the LGU's Special Education Fund (P2,000,000.00);

WHEREAS, this AIP is in accordance with Section 287 of RA 7160. Twenty percent (20%) of the LGU's IRA (P103,422,549.00), which is equivalent to P20,684,510.00 is allocated for development projects. These development programs/projects conform to the Joint DBM-DOF-DILG Memorandum Circular No. 1, dated November 4, 2020 (*Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects*);

WHEREAS, the Disaster Risk Reduction and Management Plan is integrated in the AIP 2021. However, based on the LFC review on their 2021 Annual Budget, there is a deficiency in the appropriation of 5% LDRRM Fund in the amount of P355,000.00. The deficit shall be programmed for disaster risk reduction and management programs and projects in their First Supplemental Investment Program for CY 2021 as per NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 of the Department of the Interior and Local Government (*Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund*);

WHEREAS, the LGU of Burgos had also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;

WHEREAS, the Gender and Development Programs, Projects and Activities (GAD-PPAs) attached were reviewed by the Department of Interior and Local Government (DILG) Provincial Office, and were found to be fully compliant in form and in contents with the provisions of the DBM, PCW, DILG & NEDA Joint Memorandum Circular No. 2016-01: Amendments to JMC 2013-01 re: Guidelines on the Localization of Magna Carta of Women;




