APPROVING RESOLUTION NO. 292, S-2019 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED "APPROVING THE REVISED ANNUAL INVESTMENT PLAN NUMBER 2 FOR CALENDAR YEAR 2019 OF THE MUNICIPALITY OF ASINGAN, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Resolution No. 292, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the AIP of the Municipality of Asingan, Pangasinan for CY 2019 with total investment requirement of P2,066,093,049.48 was already approved by the Sangguniang Panlalawigan on April 12, 2019 thru SP Resolution No. 205-2019;

WHEREAS, the Sangguniang Bayan of Asingan thru SB Resolution No. 82, S-2019 dated July 17, 2019 has approved the Revised CY 2019 AIP of the municipality to include the programs/projects to be funded from the accumulated 2014-2018 DRRM Fund. This was already approved by the Sangguniang Panlalawigan thru SP Resolution No. 488-2019 dated September 9, 2019;

WHEREAS, on December 20, 2019, the Local Disaster Risk Reduction Management Council of Asingan, Pangasinan thru MDRRMC Resolution No. 2, S-2019 has realigned the unspent CY 2019 – 70% of the 5% DRRM Fund amounting to P1,086,001.53 for the continuation of the construction of the LDRRM Operations Center;


