WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Resolution No, 276, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Asingan, Pangasinan has formulated the municipality's Supplemental Annual Investment Program No. 3 and endorsed thru MDC Resolution No. 37, S-2019 dated December 13, 2019. This was approved by their Sangguniang Bayan thru Resolution No. 276, S-2019. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

**WHEREAS**, the Supplemental Investment Program No. 3 of the municipality with an investment requirement amounting to P1,263,000.00 covers the implementation of the grant of the One-Time Service Recognition Incentive to municipal officials and employees;

WHEREAS, the Sangguniang Bayan enacted Supplemental Budget No. 2 through Appropriation Ordinance No. 3, S-2019 dated December 16, 2019 to support the implementation of the Supplemental Investment Program No. 3 of the municipality;
