### PROVINCIAL ORDINANCE NO. 192-2015

SUB-LOAN RATIFYING THE ORDINANCE AGREEMENT AND OTHER SUPPORTING DOCUMENTS PERTAINING TO THE LOAN ENTERED INTO BY AND BETWEEN THE PROVINCIAL GOVERNMENT PANGASINAN, REPRESENTED BY HON. AMADO T. LAND BANK THE THE ESPINO, JR. ITS REPRESENTED PHILIPPINES, PANGASINAN LENDING CENTER DM JAIME S. CRUZ JR., IN THE AMOUNT OF SEVEN HUNDRED FIFTY MILLION ONE HUNDRED **FORTY** EIGHT THOUSAND SEVEN HUNDRED EIGHT PESOS AND 38/100 (P758,149,708.38) **FUND** TO ONLY ASPHALTING/BLOCKTOPPING/CONCRETING RECONSTRUCTION/ ROADS, PROVINCIAL DAMAGED/OLD OF REPLACEMENT PROVINCIAL/BARANGAY BRIDGES, PURCHASE OF HOSPITAL/ HEAVY EQUIPMENT, CONSTRUCTION/ OF REPAIR REHABILITATION/ CONSTRUCTION/REHABILITATION OF COMMUNAL, PUMP AND SHALLOW TUBE WELL IRRIGATION SYSTEM, ACQUISITION OF HOSPITAL EQUIPMENT **EQUIPMENT** CONTROL **OUALITY** WELL NEW WATER ACQUISITION OF BRAND DRILLING RIG MOUNTED WITH TRUCK

WHEREAS, the Provincial Government of Pangasinan has applied for a loan drawdown from the approved Omnibus Term Loan Facility 2 from the Land Bank of the Philippines to finance the above-stated projects;

> WHEREAS, the said loan was already approved by the Loan Approving Group of Land Bank of the Philippines and the Governor was authorized by the Sangguniang Panlalawigan to enter into a contract/loan agreement with Land Bank of the Philippines;

> WHEREAS, the terms and conditions of the sub-loan/contract agreement are fair, just and in order;

WHEREFORE, on motion of SP Member Angel M. Baniqued, Jr., duly seconded:

BE it enacted by the Sangguniang Panlalawigan of the Provincial Government of Pangasinan in regular session assembled that:

Section 1. The sub-loan agreement, assignment and other supporting documents to the loan in the amount of Seven Hundred Fifty Eight Million One Hundred Forty Nine Thousand Seven Hundred Eight Pesos and 38/100 ONLY (P758,149,708.38) entered into by and between the Provincial Government of Pangasinan represented by HON. AMADO T. ESPINO, JR. and the Land Bank of the Philippines, represented by its Head, Pangasinan Lending Center, DM JAIME S. CRUZ JR., is hereby ratified.

**Section 2.** This Ordinance be furnished to the Governor, the Land Bank of the Philippines, the Provincial Accountant, the Provincial Auditor, all of the Province of Pangasinan, Bangko Sentral ng Pilipinas and other concerned agencies.

**Section 3.** All Ordinances, Resolutions, Executive Orders and Circulars which are found to be inconsistent with the provisions of this Ordinance are hereby repealed/amended accordingly.

## RESOLVED FURTHER AS IT IS HEREBY RESOLVED, that this Sanggunian expressly:

- Authorizing the Governor to borrow funds, negotiate and enter into a loan agreement with Land Bank of the Philippines;
- Authorizing the Governor to sign, endorse loan documents, mortgages, deed of assignments, agreements, notes and other documents pertaining to the loan obtained from Land Bank of the Philippines;

- Approving the project to be financed and this is in accordance with the approved local development plan and/or public investment program or approved annual procurement/investment program;
- d. Approving all previous representations, acts, warranties, and all terms and conditions of the loan:
- e. Authorizing the mortgage/assignment of the Internal Revenue Allotment (IRA) and other income, revenues and collection as collateral/security to the loan obtained and declaring them to be available and not restricted by law or its other obligations;
- f. Directing the LGU Treasurer and accountant to enter the loan in the appropriate books of the LGU;
- g. Designating the Land Bank of the Philippines as the LGU's official depository bank for IRA and major depository for its other deposits, revenue and collections which designation shall not be revoked while the loan obligations remain outstanding and directing the LGU Secretary to provide a copy of this Resolution to DBM or other IRAadministering office;
- Appropriating the amount for loan repayment in the LGU's annual budget until the loan, interest and other charges are fully paid;
- Authorizing the Land Bank of the Philippines to deduct for set-off and/or deduct amounts from general funds or SEF of the LGU with Land Bank of the Philippines and apply the same to the payment of the loan or any portion thereof, or interests and penalties thereon as may be deemed necessary by the Land Bank of the Philippines; and
- Waiving the confidentiality of information on investment/bank deposit.

RESOLVED FURTHER, that the terms and conditions made and entered into by and between the Provincial Government of Pangasinan and the Land Bank of the Philippines shall be the best and optimum benefit of the Provincial Government of Pangasinan and subject to the standard terms and conditions provided by Laws, Auditing and Accounting Rules and Regulations;
