#### **RESOLUTION NO. 192-2022**

DECLARING ORDINANCE NO. 165, S-2021 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE EXPANDING THE COVERAGE OF THE CHILD WELFARE CODE OF THE MUNICIPALITY OF BASISTA, PROVINCE OF PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIAN TO ENACT

**WHEREAS**, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 165, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 17 (b) (iv) and 447 (a) (5) (xiv) of R.A. No. 7160, United Nations Convention on the Right of the Child, Republic Act No. 7610 (Special Protection of Children Against Child Abuse, Exploitation and Discrimination Act), and Presidential Decree No. 603 (The Child and Youth Welfare Code);

**WHEREAS,** subject ordinance shall take effect after compliance with the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA No. 7160;
