APPROVING RESOLUTION NO. 2019-054 OF THE SANGGUNIANG BAYAN OF TAYUG, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL AIP PURSUANT TO APPROPRIATION ORDINANCE NO. 2019-004 OF THE MUNICIPALITY OF TAYUG, PANGASINAN INVOLVING AN AMOUNT OF ONE MILLION TWO HUNDRED FIFTY THOUSAND PESOS (P1,250,000,00)"

**WHEREAS**, the Sangguniang Bayan of Tayug, Pangasinan submitted its Resolution No. 2019-054 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Tayug, Pangasinan has formulated the municipality's Supplemental Investment Program No. 3 for CY 2019 and endorsed to the Sangguniang Bayan for approval thru MDC Resolution No. 2019-07 dated December 10, 2019. This was approved by their Sangguniang Bayan on December 16, 2019 thru Resolution No. 2019-054. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

**WHEREAS**, the Supplemental Investment Program of the municipality with an investment requirement amounting to P1,250,000.00 covers implementation of the grant of the One Time Service Recognition Incentive to municipal officials and employees;

**WHEREAS**, to support the implementation of the Supplemental Investment Program No. 3 of the municipality, the Sangguniang Bayan of Tayug, Pangasinan has enacted Supplemental Budget No. 3 through Appropriation Ordinance No. 004-2019 dated December 16, 2019;
