RESOLUTION NO. 197-2019

APPROVING RESOLUTION NO. 12-18-64 OF THE SANGGUNIANG BAYAN OF MABINI, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) SERIES OF 2019 OF THE LGU OF MABINI, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Mabini, Pangasinan submitted its Resolution No. 12-18-64 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Mabini, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for CY 2019. This was endorsed by the Council to the Sangguniang Bayan thru MDC Resolution No. 004, S-2018 dated October 12, 2018 and was favorably acted upon by the Sangguniang Bayan on December 3, 2018 thru SB Resolution No. 12-18-64;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. AIP of Mabini, Pangasinan was prepared using the prescribed AIP Summary Form, and covers: a) all the regular budgetary requirements for the operation of the different offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, c) Disaster Risk Reduction (DRR) Programs/Projects/Activities, d) Local Climate Change Action Plan, e) Peace and Order Plan, f) Local Nutrition Action Plan and g) Activities in pursuance of the objectives of GAD of the LGU, Local Council for the Protection of Children, Senior Citizens and Persons with Disabilities and Programs/Projects/Activities to combat AIDS;

WHEREAS, the AIP of Mabini for CY 2019 has an investment requirement of P123,616,101.00. Funding support for the implementation of the AIP is embodied in their 2019 Annual Budget passed and approved by the Sangguniang Bayan through Appropriation Ordinance No. 3, S-2018 dated December 3, 2018;

WHEREAS, said AIP is in accordance with Section 287 of RA 7160. Twenty percent (20%) of the LGUs IRA (P116,282,401.00) which is equivalent to P23,256,480.20 is allocated for development projects. The development projects proposed to be funded by the 20% development fund were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the Disaster Risk Reduction and Management Plan in preparation for and to mitigate the impact of disasters to be funded by the 5% LDRRM Fund (P6,054,755.05) is in conformity to Section 21 of RA 10121. The programs/projects/activities to be funded by 70% of the 5% LDRRM Fund in the amount of P4,238,328.54 were based on NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). **However, the DRRM Plan shall be submitted by the municipality to the Office of Civil Defense (OCD) for review as provided under Item No. 2.2.12 of the Department of Budget and Management as per Local Budget Memorandum No. 77 dated May 15, 2018;**

WHEREAS, the LGU of Mabini had also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;
