APPROVING RESOLUTION NO. 287, S-2021 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED “APPROVING THE MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NUMBER 8 WITH THE CY 2021 SUPPLEMENTAL ANNUAL INVESTMENT PLAN NUMBER 7 OF THE MUNICIPALITY OF ASINGAN, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Resolution No. 287, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R. A. 7160;

WHEREAS, the Local Development Council of Asingan, Pangasinan formulated and endorsed Supplemental Investment Plan No. 7 through MDC Resolution No. 8, S-2021 to the Sangguniang Bayan for approval;

WHEREAS, Supplemental Investment Plan No. 8 with an investment requirement amounting to P1,025,000.00 covers the grant of gratuity pay to Contract of Service (COS) and Job Order (JO) workers of LGU Asingan;

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan enacted Supplemental Budget No. 7 through Appropriation Ordinance No. 8, S-2021 dated December 31, 2021 to support the implementation of Supplemental Investment Program No. 7 of the municipality;
