APPROVING RESOLUTION NO. 133-2020 OF THE SANGGUNIANG BAYAN OF BURGOS, PANGASINAN, ENTITLED “APPROVING SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 06 FOR THE CALENDAR YEAR 2020 OF THE MUNICIPALITY OF BURGOS, PROVINCE OF PANGASINAN”

WHEREAS, the Sangguniang Bayan of Burgos, Pangasinan submitted its Resolution No. 133-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Burgos, Pangasinan had identified items in their Supplemental Investment Program No. 6 for CY 2020. This was endorsed to the Sangguniang Bayan for approval on December 21, 2020 by the Municipal Development Council thru Resolution No. 2020-007;

WHEREAS, the Supplemental Investment Program No. 6 of the municipality covers fund augmentation for the Personal Services (granting of Service Recognition Incentive to officials and employees of the municipality;

WHEREAS, the proposed Supplemental Investment Program has an investment requirement of P880,000.00. Funding support for the implementation of the same is embodied in their proposed Supplemental Budget No. 06-2020, which was enacted by their Sangguniang Bayan on December 22, 2020 through Appropriation Ordinance No. 07, S-2020;


