DECLARING RESOLUTION NO. 181, S-2018 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED "APPROVING THE PROJECTS IDENTIFIED BY THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (MDRRMC) TO BE FUNDED FROM THE QUICK RESPONSE TRUST FUND OF THE MUNICIPALITY OF ASINGAN, PANGASINAN AMOUNTING TO SEVEN MILLION TWO HUNDRED THOUSAND PESOS (P7,200,000.00)" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan submitted its Resolution No. 181, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer and the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same was enacted pursuant to Section 447 (a) (1) (2) (i) of RA 7160 and Section 2 (e) of RA 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010;
