**DECLARING RESOLUTION NO. 188, S-2018 OF THE SANGGUNIANG BAYAN OF ASINGAN, PANGASINAN, ENTITLED “APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) FOR THE UTILIZATION OF THE QUICK RESPONSE FUND (QRF) TRUST FUND OF THE MUNICIPALITY OF ASINGAN, PANGASINAN” AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Asingan, Pangasinan submitted its Resolution No. 188, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer and the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same was enacted in support of Resolution No. 181-2018 to enable the Sanggunian to release and utilize the unexpended balance of the LDRRMF in compliance with Section 6.5 of Joint Memorandum Circular No. 2013-01 of the National Disaster Risk Reduction and Management Council-Department of Budget and Management-Department of the Interior and Local Government;
