PROVINCIAL ORDINANCE NO. 215-2017

AN ORDINANCE NAMING THE PANGASINAN POLICE PROVINCIAL OFFICE AS CAMP ANTONIO SISON

WHEREAS, one the main thrusts of the present administration is to streamline the Philippine National Police (PNP) and turn it into a world-class police force in all aspects;

WHEREAS, among the strategies of the Pangasinan Police Provincial Office (PPPO), under the leadership of Provincial Director Ronald O. Lee, is to uphold the tradition of naming police camps after persons who are no longer living but whose deeds or character traits are exemplary;

WHEREAS, among the four provincial headquarters of the PNP in Region 1, only the PPPO has not yet been named after any individual and therefore, after a thorough discussion between and among the concerned authorities, a consensus was arrived at to name it after the donor of the land where the PPPO stands in the person of the late Governor Antonio U. Sison;

WHEREAS, Governor Antonio U. Sison was one of the illustrious sons the Province of Pangasinan has ever had as can be gleaned from the annals of history of the Province during his incumbency as the 4th Provincial Governor of the Province from 1908-1910;

WHEREAS, the magnanimous gesture of the family of the late Governor Antonio Sison will long be remembered by the people of Pangasinan through the naming of the PPPO in honor of him;

WHEREFORE, in view of the foregoing, on motion of SP Member Noel C. Bince, duly seconded -

Be it enacted by the Sangguniang Panlalawigan in session assembled that:

SECTION 1. TITLE – This ordinance shall be known as "AN ORDINANCE NAMING THE PANGASINAN POLICE PROVINCIAL OFFICE AS CAMP ANTONIO SISON."

SECTION 2. The renaming of the Pangasinan Police Provincial Office into Camp Antonio Sison is an act to commemorate the remarkable contributions of the past Governors of this Province toward achieving further progress and development in Pangasinan.

SECTION 3. EFFECTIVITY. This Ordinance shall take effect upon its approval and upon consultation with the National Historical Commission of the Philippines as provided for under Section 13, par. (a) (5) (d) of RA 7160, otherwise known as the Local Government Code of 1991.
