## RESOLUTION NO. 215-2019

### **DECLARING THE ANNUAL BUDGET FOR CALENDAR YEAR 2019 OF TAYUG, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P166,222,232.70 OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Tayug, Pangasinan submitted its Annual Budget for Calendar Year 2019 involving total appropriations of **P166,222,232.70** which was approved on November 8, 2018 through Appropriation Ordinance No. 2018-002;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. The full implementation of the Fourth Tranche Compensation Adjustment for Local Government Personnel shall be subject to the provisions of Local Budget Circular No. 118 of the Department of Budget and Management dated January 15, 2019, specifically Sub-Item No. 5.2 thereof;

2. The grant of step increment to some municipal officials and employees shall be in accordance with CSC-DBM Joint Circular No. 1, S-2012 dated September 3, 2012;
3. The purchase of Motor Vehicle/s shall be subject to the provisions of Budget Circular No. 2017-1 of the Department of Budget and Management dated April 26, 2017 re: Amending Budget Circular No. 2016-05 entitled "Revised Guidelines on the Acquisition and Use of Government Motor Vehicles" dated August 22, 2016;
4. The items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with RA No. 10121 known as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR and the DBM-NDRRM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re: Allocation and Utilization of the Local Risk Reduction and Management Fund (LDRRMF) and that 30% shall be set aside as Quick Response Fund;
5. The projects funded under the 20% of the Annual Internal Revenue Allotment for development projects (20% Development Fund) shall be subject to the provisions of DILG and DBM JMC No. 2017-1 dated February 22, 2017 re "Updated Guidelines on the Appropriation and Utilization of the twenty percent (20%) of the Annual Internal Revenue Allotment for Development Projects" and DILG Memorandum Circular No. 2010-138 dated December 2, 2010, entitled "Use of the 20% Component of the Annual Internal Revenue Allotment Shares";
6. All procurements to be undertaken shall be subject to the pertinent provisions of RA No. 9184 (The Government Procurement Reform Act) and its revised Implementing Rules and Regulations;
7. There is an excess appropriation for 5% Local Disaster Risk Reduction and Management Fund amounting to P528,250.00. Pursuant to Section 324 (d) of RA 7160, as amended by RA 10121, Local Economic Enterprise income is specific for LEE operations and not for regular LGU operations;


**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the same in order provided that the above-findings shall be complied with by the municipality;
