APPROVING RESOLUTION NO. 93-2020 OF THE SANGGUNIANG BAYAN OF SAN JACINTO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 3 CY 2020 OF THE MUNICIPALITY OF SAN JACINTO, PANGASINAN"

WHEREAS, the Sangguniang Bayan of San Jacinto, Pangasinan submitted its Resolution No. 93-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council of San Jacinto prepared the municipality's Supplemental Investment Program No. 3 for CY 2020. This was endorsed by the Council, through MDC Resolution No. 2020-05 dated October 2, 2020 to the Sangguniang Bayan for approval. The Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 93-2020 dated December 11, 2020;

WHEREAS, the municipality's Supplemental Investment Program, which has a total investment requirement of P11,535,000.00 covers various development projects of the LGU;

WHEREAS, the proposed projects to be funded by the 20% Development Fund conforms with DILG and DBM Joint Memo-Circular No. 2017-1 dated February 22, 2017 (Updated Guidelines on the Appropriation and Utilization of the 20% of the IRA for Development Projects);
