**RESOLUTION NO. 219-2020**

**DECLARING THE SUPPLEMENTAL BUDGET NO. 3 FOR CALENDAR YEAR 2019 OF BAUTISTA, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P1,084,288.32 OPERATIVE IN ITS ENTIRETY**

**WHEREAS**, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS**, the Sangguniang Bayan of Bautista, Pangasinan submitted its Supplemental Budget No. 3 for Calendar Year 2019 involving total appropriations of **P1,084,288.32** which was approved on December 16, 2019 through Appropriation Ordinance No. 4, S-2019;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the finding that the grant of One-Time Service Recognition Incentive for FY 2019 for municipal officials and employees shall be in accordance with the provisions of Budget Circular No. 2019-6 dated December 9, 2019 of the Department of Budget and Management specifically Item 8.1 thereof;

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the same in order provided that the above-finding shall be complied with by the municipality;


