APPROVING RESOLUTION NO. 20-086 OF THE SANGGUNIANG PANLUNGSOD OF SAN CARLOS, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 11 FOR CALENDAR YEAR 2020 OF THE CITY OF SAN CARLOS, PROVINCE OF PANGASINAN"

WHEREAS, the Sangguniang Panlungsod of San Carlos, Pangasinan submitted its Resolution No. 20-086 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the City Development Council – Executive Committee of San Carlos City, Pangasinan prepared the City's Supplemental Investment Program (SIP) No. 11 for CY 2020. This was endorsed by the Council thru CDC Resolution No. 21-20 (Series of 2020) dated November 18, 2020 to the Sangguniang Panlungsod for approval;

WHEREAS, said Supplemental AIP No. 11, CY 2020, which has a total investment requirement of P500,000.00, covers the procurement of relief goods for the typhoon victims of Cagayan Province/s;

WHEREAS, funding for the Supplemental AIP will be sourced from the realignment of funds of some projects from the 2020 Local Disaster Risk Reduction and Management Fund;

WHEREAS, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order, however, compliance with all existing laws, rules and regulations shall be the responsibility of the City Government of San Carlos;
