**APPROVING RESOLUTION NO. 125, S-2018 OF THE
SANGGUNIANG BAYAN OF BASISTA, PANGASINAN,
ENTITLED "APPROVING THE ANNUAL INVESTMENT
PROGRAM (AIP) FOR CALENDAR YEAR 2019 OF THE
MUNICIPALITY OF BASISTA, PANGASINAN"**

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Resolution No. 125, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Basista, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for CY 2019. This was endorsed by the Local Development Council to the Sangguniang Bayan on September 21, 2018 thru MDC Resolution No. 5, S-2018 and was favorably acted upon by the Sangguniang Bayan on December 17, 2018 thru SB Resolution No. 125, S-2018;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-

DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Basista, Pangasinan was formulated following the prescribed AIP Summary Form, and covers: a) all the regular budgetary requirements for the operation of the different city offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, c) Disaster Risk Reduction (DRR) Programs/Projects/Activities, d) Local Climate Change Action Plan, e) Peace and Order Plan, f) Local Nutrition Action Plan, and g) Activities in pursuance of the objectives of GAD, Local Council for the Protection of Children, Senior Citizens and Persons with Disabilities of the LGU;

WHEREAS, the proposed AIP of Basista for CY 2019 has an investment requirement of P194,929,026.39. Funding support for the implementation of which is embodied in their 2019 proposed Annual Budget, in the amount of P100,270,026.39 which was passed and approved by their Sangguniang Bayan on December 3, 2018 through Appropriation Ordinance No. 3, S-2018, and national government agencies in the amount of P94,659,000.00. **The AIP should be prepared and approved before the start of the local budget preparation phase, as provided in Article 410 of the IRR of RA 7160;**

WHEREAS, this AIP is in accordance with Section 287 of RA 7160. Twenty percent (20%) of the LGUs IRA (P91,203,464.00) which is equivalent to P18,240,692.80 is allocated for development projects. The development projects proposed to be funded by 20% development fund were based on DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the Disaster Risk Reduction and Management Plan in preparation for and to mitigate the impact of disasters to be funded by the 5% LDRRM Fund (P4,902,673.20) is in conformity to Section 21 of RA 10121. The programs/projects/activities to be funded by 70% of the 5% LDDRM Fund in the amount of P3,431,871.24 were based on NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). The DRRM Plan was reviewed by the Office of the Civil Defense (OCD) Regional Office using the Provincial Review Tool and Checklist for the conduct of review of local DRRM Plans. **However, the LGU should comply with the recommendations of the OCD-RO1 as per their review of their LDRRMP;**

WHEREAS, the Gender and Development Programs, Projects and Activities (GAD-PPAs) attached were reviewed by the Department of Interior and Local Government (DILG) Provincial Office, and were found to be fully compliant in form and in contents with the provisions of the DBM, PCW, DILG & NEDA Joint Memorandum Circular No. 2016-01 entitled "Amendments to JMC 2013-01 or the Guidelines on the Localization of Magna Carta of Women";

WHEREFORE, in view of the foregoing, on motion of SP Members Raul P. Sison and Nestor D. Reyes and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Arth Bryan C. Celeste, duly seconded, it was –
