**APPROVING RESOLUTION NO. 2019-290 OF THE SANGGUNIANG BAYAN OF SISON, PANGASINAN, ENTITLED "APPROVING THE 2<sup>ND</sup> SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM CY 2019 OF THE MUNICIPALITY OF SISON, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Sison, Pangasinan submitted its Resolution No. 2019-290 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Sison, Pangasinan has formulated the municipality's 2<sup>nd</sup> Supplemental Investment Program for CY 2019 and endorsed thru MDC Resolution No. 05, S-2019 dated December 19, 2019 to the Sangguniang Bayan for approval. The Sangguniang Bayan approved the 2<sup>nd</sup> Supplemental Investment Program on December 23, 2019 thru Resolution No. 2019-290. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

**WHEREAS**, the 2<sup>nd</sup> Supplemental Investment Program of Sison, Pangasinan covers the provision of Collective Negotiation Agreement (CNA) and Service Recognition Incentives of municipal officials and employees and implementation of development projects to be funded by national government agencies, e.g. Department of Agriculture (DA) and Department of Tourism (DOT);

**WHEREAS**, the said supplemental investment program has an investment requirement of P94,928,100.00. The amount of P2,928,100.00 will be supported by the municipality's Supplemental Budget No. 2 which was enacted by the Sangguniang Bayan on December 23, 2019 through Appropriation Ordinance No. 04, S-2019 while the remaining amount of P92,000,000.00 will be funded by the Department of Agriculture and Department of Tourism;
