#### **RESOLUTION NO. 220-2022**

DECLARING THE SUPPLEMENTAL BUDGET NO. 8 FOR CALENDAR YEAR 2021 OF AGNO, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P720,000.00, OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

**WHEREAS,** the Sangguniang Bayan of Agno, Pangasinan submitted its Supplemental Budget No. 08 for Calendar Year 2021 involving total appropriations of P720,000.00, which was enacted on December 31, 2021 through Appropriation Ordinance No. 2021-09;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

- 1. That the reversion of savings from Maintenance and Other Operating Expenses shall be in accordance with the provisions of Section 336 of R.A. No. 7160 (Use of Appropriated Funds and Savings); and
- 2. That the grant of Gratuity Pay to Contract of Service and Job Workers in the municipality for FY 2021 shall be in accordance with Budget Circular No. 2021-5 dated December 31, 2021.
