RESOLUTION NO. 222-2019

DECLARING ORDINANCE NO. 102, S-2018 OF THE SANGGUNIANG BAYAN OF BASISTA, PANGASINAN, ENTITLED "AN ORDINANCE INSTITUTIONALIZING THE BENEFITS AND PRIVILEGES OF THE SENIOR CITIZENS OF BASISTA WITH THE FUNDS TO BE SOURCED FROM THE SENIOR CITIZENS FUND OF THE LOCAL GOVERNMENT OF BASISTA, PANGASINAN AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Basista, Pangasinan submitted its Ordinance No. 102, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 447 (a) (5) (xvi) of RA 7160; and RA No. 9994 otherwise known as Expanded Senior Citizens Act of 2010;

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with all the requirements of posting and publication pursuant to Sections 59 (c) and 511 (a) of RA 7160;
