#### **RESOLUTION NO. 222-2020**

APPROVING RESOLUTION NO. 2019-285 OF THE SANGGUNIANG BAYAN OF SISON, PANGASINAN, ENTITLED "APPROVING THE ANNUAL INVESTMENT PROGRAM CY 2020 OF THE MUNICIPALITY OF SISON, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Sison, Pangasinan submitted its Resolution No. 2019-285 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Sison, Pangasinan has formulated the municipality's Annual Investment Program for Calendar Year 2020 and endorsed thru MDC Resolution No. 04-2019 dated October 11, 2019 to the Sangguniang Bayan for approval. This was approved by their Sangguniang Bayan through Resolution No. 2019-285 dated December 16, 2019. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-1 dated August 7, 2014 as amended by DBM-CCC-DILG JMC No. 2015-1 dated July 23, 2015 as to format and content. The AIP of Sison, Pangasinan was formulated following the prescribed AIP Summary Form categorized into general public, social, economic and other service sectors and covers: a) all the regular budgetary items for the operation of the different municipal offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority development programs/projects of the LGU including those to be funded by the 20% development fund, and c) Disaster Risk Reduction (DRR) Management Programs/Projects/Activities

of the municipality. It also includes the following: a) Gender and Development Plan, Local Climate Change Action Plan, Peace and Order Plan, Annual Cultural Development Plan, Nutrition Plan and 2) list of programs/ projects for the Local Council for Senior Citizens and Persons with Disabilities, for the Protection of Children, and to combat AIDS;

**WHEREAS,** the AIP of Sison, Pangasinan has a total investment requirement amounting to P182,919,582.00 to be funded by the municipality's Annual Budget which was enacted on December 16, 2019 through Appropriation Ordinance No. 33, S-2019;

**WHEREAS,** the development fund amounting to P28,018,516.00 which is allocated for development projects is twenty percent (20%) of the LGU's IRA (P140,092,582.00) for CY 2020. This is in accordance with Section 287 of RA 7160;

WHEREAS, the identified development programs/projects to be funded by the 20% of IRA were based on the DILG-DBM Joint Memorandum Circular No. 2017-1, dated February 22, 2017 entitled "Updated Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects";

WHEREAS, the programs/projects/activities identified to be funded by the 5% Local Disaster Risk Reduction and Management Fund of the municipality amounting to P8,982,729.00 conforms with Section 21 of RA 10121 and NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013(Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). Further, the LDRRMF Plan of the municipality was reviewed and a certification was issued by the Office of Civil Defense (OCD) dated December 3, 2019;

WHEREAS, the Gender and Development Plan of the municipality was already reviewed by the Department of Interior and Local Government (DILG) Provincial Office, and found to be fully compliant in form and in contents with the provisions of the DBM, PCW, DILG & NEDA Joint Memorandum Circular No. 2016-01 entitled "Amendments to JMC 2013-01 or the Guidelines on the Localization of Magna Carta of Women as per Certificate of Review and Endorsement of the DILG dated March 20, 2019";

**WHEREAS**, the Sangguniang Panlalawigan, after final evaluation, finds the subject resolution in order;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Rosary Gracia P. Perez-Tababa and Nicholi Jan Louie Q. Sison and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jose G. Peralta, Jr., duly seconded, it was –
