APPROVING RESOLUTION NO. 2019-136 OF THE SANGGUNIANG BAYAN OF BALUNGAO, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (SAIP) NO. 5 FOR THE CALENDAR YEAR 2019 OF THE MUNICIPALITY OF BALUNGAO, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Balungao, Pangasinan submitted its Resolution No. 2019-136 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Balungao, Pangasinan has formulated the municipality's Supplemental Annual Investment Program No. 5 for CY 2019 and endorsed to the Sangguniang Bayan for approval thru MDC Resolution No. 2019-08 dated December 4, 2019. The Sangguniang Bayan approved the Supplemental Annual Investment Program No. 5 on December 11, 2019 thru Resolution No. 2019-136. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

**WHEREAS**, the Supplemental Annual Investment Program No. 5 with an investment requirement amounting to P3,181,549.00 covers fund augmentation for the maintenance and other operating expenses of Office of the Mayor;

**WHEREAS**, the Sangguniang Bayan of Balungao enacted Supplemental Budget No. 4 through Appropriation Ordinance No. 2019-04 dated December 11, 2019 to support the implementation of the Supplemental Annual Investment Program No. 5 of the municipality;
