APPROVING SB RESOLUTION NO. 63, S-2021 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM NO. 06 CY 2021 OF THE MUNICIPALITY OF BANI, PANGASINAN"

WHEREAS, the Sangguniang Bayan of Bani, Pangasinan submitted its SB Resolution No. 63, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Local Development Council of Bani, Pangasinan had identified items in this Supplemental Investment Program No. 6 CY 2021 which was endorsed to the Sangguniang Bayan for approved on December 27, 2021 through MDC Resolution No. 2021-11;

WHEREAS, Supplemental Investment Program No. 6 covers fund augmentation for the Personal Services (granting of Service Recognition Incentive to all officials and employees) and Maintenance and Other Operating Expenses of some municipal offices of the LGU;

WHEREAS, funding support for the implementation of the same in the amount of P5,720,000.00 is embodied in the Supplemental Budget No. 06 CY 2021, which was enacted by the Sangguniang Bayan on December 31, 2021 through Appropriation Ordinance No. 08, S-2021;
