**APPROVING RESOLUTION NO. 2021-188 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 6 CY 2021 OF SUAL, PANGASINAN AMOUNTING TO TWO MILLION SEVEN HUNDRED SEVENTY FIVE THOUSAND PESOS (P2,775,000.00)"**

**WHEREAS**, the Sangguniang Bayan of Sual, Pangasinan submitted its Resolution No. 2021-188 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R. A. 7160;

**WHEREAS**, the Local Development Council of Sual, Pangasinan had identified items in this Supplemental Investment Program No. 6 for CY 2021 which was endorsed to the Sangguniang Bayan for approved on December 31, 2021 through MDC Executive Committee Resolution No. 4, S-2021;

**WHEREAS**, the said Supplemental Investment Program covers fund augmentation for the Personal Services (granting of gratuity pay to contract of service and job order workers);
