#### **PROVINCIAL RESOLUTION NO. 238-2020**

INVITING THE DPWH 2<sup>ND</sup> PANGASINAN ENGINEERING DISTRICT, CONGRESSMAN JUMEL ANTHONY I. ESPINO OR HIS AUTHORIZED REPRESENTATIVE, MAYORS LEOPOLDO N. BATAOIL, RAMIL P. VENTENILLA AND ROLDAN C. SAGLES TO A QUESTION HOUR OF THE SANGGUNIANG PANLALAWIGAN DURING ITS MARCH 2, 2020 REGULAR SESSION TO BRIEF THE AUGUST BODY ON THE PROGRESS AND PRESENT STATUS OF THE CONSTRUCTION OF THE DAANG KALIKASAN ROAD AND OTHER RELATED ISSUES SURROUNDING THE SAME

WHEREAS, the Daang Kalikasan Road has become a favorite haven or tourist attraction in the Province of Pangasinan for the past months as it has been frequently visited by the townspeople and even local and foreign tourists;

**WHEREAS**, at present, however, the Daang Kalikasan Road has been reportedly closed temporarily due to its completion and to prevent any further accidents thereat;

WHEREAS, it is the intention of the Sangguniang Panlalawigan to schedule the Question Hour primarily to know from the concerned authorities the classification of the Daang Kalikasan Road in order to determine what agency or local government unit would be responsible or accountable for the maintenance of the road, including public safety, peace and order, and the cleanliness of the area as it has now become an alleged dumpsite of garbage;

WHEREAS, the Sangguniang Panlalawigan fully supports the construction of the Daang Kalikasan Road as it aims to provide transportation and infrastructure support in Northern Luzon to further boost trade and tourism, however, it is also the desire of the Body to be informed of the actions being undertaken by the authorities to solve the issues surrounding the same;
