APPROVING RESOLUTION NO. 59, S-2021 OF THE SANGGUNIANG BAYAN OF BUGALLON, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 5 FOR FY 2021 OF THE MUNICIPALITY OF BUGALLON, PROVINCE OF PANGASINAN INVOLVING THE AMOUNT OF TEN MILLION FIVE HUNDRED FIVE THOUSAND SIX HUNDRED THIRTY EIGHT PESOS AND NINETY SEVEN CENTAVOS (P10,505,638.97)"

WHEREAS, the Sangguniang Bayan of Bugallon, Pangasinan submitted its Resolution No. 59, S-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the same is in pursuant to Sections 106, 109 and 114 of R. A. 7160;

WHEREAS, the Local Development Council of Bugallon, Pangasinan had identified items in this Supplemental Investment Program No. 5 for CY 2021 which was endorsed to the Sangguniang Bayan for approved on December 14, 2021 through MDC Resolution No. 8, S-2021;

WHEREAS, Supplemental Investment Program No. 5 covers fund augmentation for the Personal Services (granting of Collective Negotiation Agreement to all municipal officials and employees and terminal leave benefits), Maintenance and Other Operating Expenses and Capital Outlay of some LGU offices and implementation of development projects;
