APPROVING RESOLUTION NO. 45, S-2018 OF THE SANGGUNIANG BAYAN OF AGUILAR, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN OF SUPPLEMENTAL BUDGET NO. 02 CY 2018"

**WHEREAS**, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Resolution No. 45, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Aguilar, Pangasinan had identified items in their Supplemental Investment Program No. 2 for CY 2018 with a total investment requirement of P10,668,669.56. This was endorsed to the Sangguniang Bayan for approval on May 31, 2018 thru MDC Resolution No. 1, S-2018 and was favorably acted upon by the Sangguniang Bayan on October 15, 2018 thru SB Resolution No. 45, S-2018;

WHEREAS, the Supplemental Investment Program No. 2 covers the granting of salary increase and other personal benefits to all officials and employees of the municipal government of Aguilar and implementation of disaster risk reduction and management and programs and projects of the municipality. The LGU shall abide with the guidelines on the utilization of LDRRMF;
