**APPROVING RESOLUTION NO. 2019-194 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED "APPROVING AND ADOPTING THE SUPPLEMENTAL ANNUAL INVESTMENT PROGRAM (AIP) NO. 1, CY 2019 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN"**

**WHEREAS**, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Resolution No. 2019-194 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Municipal Development Council – Executive Committee of Mangaldan, Pangasinan has prepared the municipality's Supplemental Annual Investment Program No. 1 for CY 2019. This was endorsed by the Council thru MDC Resolution No. 1, S-2019 dated November 7, 2019 to the Sangguniang Bayan for approval. The Sangguniang Bayan approved said endorsement through Sangguniang Bayan Resolution No. 2019-194 dated November 8, 2019;

**WHEREAS**, said Supplemental Investment Program, which has a total investment requirement of P7,928,080.62 is intended for security and janitorial services, and human resource management services of the LGU;

**WHEREAS**, funding support for this Supplemental AIP is embodied in the municipality's Supplemental Budget No. 1, FY 2019 of the LGU, and approved and enacted by the Sangguniang Bayan through Appropriation Ordinance No. 2019-113 dated November 8, 2019;
