RESOLUTION NO. 243-2019

DECLARING THE SUPPLEMENTAL BUDGET NO. 2 FOR CALENDAR YEAR 2018 OF ANDA, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P669,374.96 OPERATIVE IN ITS ENTIRETY

WHEREAS, pursuant to R.A. No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Anda, Pangasinan submitted its Supplemental Budget No. 2 for Calendar Year 2018 involving total appropriations of **P669,374.96** which was approved on December 27, 2018 through Appropriation Ordinance No. 03, S-2018 and was approved by the Municipal Mayor on February 7, 2019;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the finding that the grant of Collective Negotiations Agreement Incentive for FY 2018 to municipal officials and employees shall be subject to the provisions of Budget Circular No. 2018-5 of the Department of Budget and Management dated November 14, 2018;
