PROVINCIAL ORDINANCE NO. 245-2020

AN ORDINANCE NAMING THE MOLECULAR DIAGNOSTICS LABORATORY LOCATED AT SAN CARLOS CITY, PANGASINAN AS PANGASINAN MOLECULAR DIAGNOSTICS LABORATORY

WHEREAS, the Pangasinan Molecular Diagnostics Laboratory located at the Pangasinan Provincial Hospital in Barangay Bolingit, San Carlos, Pangasinan is now ready and open for operation;

WHEREAS, the Pangasinan Molecular Diagnostics Laboratory was established to cater to the needs of the people of Pangasinan and nearby localities for various COVID-19 related activities in order to help the country in the fight against the pandemic;

WHEREAS, with the molecular diagnostics laboratory operating in Pangasinan, it would foster faster processing of RT-PCR test results for a shorter period of time;

WHEREAS, the Pangasinan Molecular Diagnostics Laboratory would add on to the existing COVID-19 testing laboratories in the Region;

WHEREAS, it is important for the molecular diagnostics laboratory to have an official name to be clearly and easily identified and located by the general public;

WHEREFORE, on motion of SP Member Jeremy Agerico B. Rosario, duly seconded, it was –

SECTION 1. Title. – This Ordinance shall be known as Pangasinan Molecular Diagnostics Laboratory.

SECTION 2. In light with the efforts of the Provincial Government to expand and facilitate COVID-19 testing and other tests in Pangasinan, the Pangasinan Molecular Diagnostics Laboratory shall serve an important health facility to curb the spread of the disease.







SECTION 3. Effectivity. – This Ordinance shall take effect upon approval.


