**APPROVING RESOLUTION NO. 02, S-2019 OF THE SANGGUNIANG BAYAN OF AGUILAR, PANGASINAN, ENTITLED "APPROVING THE SUPPLEMENTAL ANNUAL INVESTMENT PLAN OF SUPPLEMENTAL BUDGET NO. 01 CY 2019"**

**WHEREAS**, the Sangguniang Bayan of Aguilar, Pangasinan submitted its Resolution No. 02, Series of 2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109 and 114 of RA 7160. The Local Development Council of Aguilar, Pangasinan had identified items in their Supplemental Investment Program No. 1 for CY 2019. This was endorsed to the Sangguniang Bayan for approval on February 4, 2019 thru MDC Resolution No. 1, S-2019 and was favorably acted upon by the Sangguniang Bayan on February 12, 2019 thru SB Resolution No. 02, S-2019;

**WHEREAS**, the Supplemental Investment Program No. 1 of the municipality covers the fund augmentation for Personal Services and Other Operating Expenses of various municipal offices and the implementation of disaster risk reduction programs and projects of the municipality;

**WHEREAS**, the Supplemental Investment Program No. 1 has an investment requirement of P3,771,733.69. Funding support for the implementation of the same is embodied in Supplemental Budget No. 1, CY 2019 in the amount of P3,713,557.62 which was approved and enacted by their Sangguniang Bayan on February 12, 2019 thru Appropriation Ordinance No. 01, S-2019;


**WHEREAS**, the remaining P58,176.05 is part of the 5% LDRRMF CY 2019 of the municipality, which was initially intended to fund the “Other Expenses” but it should be specified and must be in accordance with and in conformity to NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 of the DILG;
