PROVINCIAL RESOLUTION NO. 250-2022

AUTHORIZING THE PROVINCIAL GOVERNOR, AMADO I. ESPINO III, TO ENTER INTO AND SIGN A SUPPLEMENTAL MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF AGRICULTURE FOR THE MODIFICATION OF THE MOA DATED DECEMBER 03, 2021 FOR THE ENHANCED KADIWA FINANCIAL GRANT ASSISTANCE PROGRAM

WHEREAS, SP Provincial Resolution No. 901-2021, dated October 25, 2021, authorized the Provincial Governor Amado I. Espino III to enter into and sign a Memorandum of Agreement (MOA) with the Department of Agriculture (DA) for the provision of seed funds for the establishment of food processing facility and procurement of delivery truck under the enhanced “Kadiwa ni Ani at Kita Financial Grant Assistance Program”;

WHEREAS, a Memorandum of Agreement (MOA) for the Program was executed between the Province of Pangasinan and the Department of Agriculture and was notarized on December 03, 2021;

WHEREAS, under the Program, the Department of Agriculture shall download funds to PLGU-Pangasinan in the amount of P5,000,000.00 only;

WHEREAS, upon processing on the fund release, the Department of Agriculture-Accounting Office recommended the modification of the said MOA to include the provision relative to ownership of purchased equipment and facilities;

WHEREAS, there is a need therefore to include and stipulate certain provisions under Article III (Obligations of PLGU-Pangasinan) and Article IV (Other Terms and Conditions) of the said MOA which pertains to the ownership of the equipment/facilities which initially belong to DA and will thereafter be transferred to PLGU-Pangasinan, upon compliance of full liquidation of the grant;
