**APPROVING SB RESOLUTION NO. 67, S-2018 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED “APPROVING THE REALIGNMENT OF THREE MILLION SIX HUNDRED FORTY SIX THOUSAND SIX HUNDRED FIFTY EIGHT PESOS (P3,646,658.00) FROM THE APPROPRIATIONS OF PUBLIC MARKET/SLAUGHTERHOUSE FOR CY 2018 UNDER THE 20% MUNICIPAL DEVELOPMENT FUND (MDF) CY 2018 FOR THE SITE DEVELOPMENT PROJECT FOR DACAP NORTE CORE SHELTER ASSISTANCE PROGRAM OF THIS MUNICIPALITY”**

**WHEREAS**, the Sangguniang Bayan of Bani, Pangasinan submitted its SB Resolution No. 67, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the proposal for realignment emanated from the Local Development Council and was endorsed to the Sangguniang Bayan for approval thru MDC Resolution No. 2018-08 on November 8, 2018 and was favorably acted upon by the Sangguniang Bayan on November 26, 2018 thru SB Resolution No. 67, S-2018;

**WHEREAS**, the fund to be realigned is a part of appropriation for 20% development fund project in AIP 2018 entitled: “*Public Market/Slaughterhouse*” amounting to P3,646,658.00. The said appropriation was expended for the purpose because there is an available funding source from the national government for the Improvement/Rehabilitation of Public Market/Slaughterhouse in their municipality, as stated in paragraph 3 of the above subject resolution;


**WHEREAS**, the purpose of realignment is to fund a new project “Site Development for the Dacap Norte Core Shelter Assistance Program” with a total funding requirement of P3,646,658.00, and is within the same expense class. However, since this is a new project, the same shall be included in the Supplemental Investment Program of the municipality;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Napoleon C. Fontelera, Jr. and Antonio F. Sison and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Arth Bryan C. Celeste, duly seconded, it was –

**RESOLVED**, by the Sangguniang Panlalawigan in session assembled, to approve SB Resolution No. 67, S-2018 of the Sangguniang Bayan of **Bani**, Pangasinan, entitled “Approving the realignment of Three Million Six Hundred Forty Six Thousand Six Hundred Fifty Eight Pesos (P3,646,658.00) from the appropriations of Public Market/Slaughterhouse for CY 2018 under the 20% Municipal Development Fund (MDF) CY 2018 for the site development project for Dacap Norte Core Shelter Assistance Program of this municipality”;
