PROVINCIAL ORDINANCE NO. 256-2021

AN ORDINANCE APPROVING THE IMPLEMENTATION OF THE AMENDED PROGRAMS AND PROJECTS TO BE FUNDED BY THE SHARE OF THE PROVINCE FROM THE FY 2017 COLLECTION OF BURLEY AND NATIVE TOBACCO EXCISE TAX UNDER RA 8240 AS AMENDED BY RA 10351

WHEREAS, the share of the Province from the FY 2017 Collection of Excise Tax on Burley and Native Tobacco Excise Tax pursuant to RA No. 8240 as amended by RA No. 10351 is P55,731,891.00;

WHEREAS, pursuant to DBM Local Budget Memorandum No. 81, dated November 4, 2020, the programs and projects to be funded by the share from Tobacco Excise Tax shall be approved by the Sangguniang Panlalawigan;

WHEREAS, the Sangguniang Panlalawigan fully supports the implementation of the amended programs and projects for the upliftment and economic development of Pangasinense farmers of the Province;

NOW, THEREFORE, on motion of SP Member Angel M. Baniqued, Jr. and co-authored by all Members of the Sangguniang Panlalawigan, duly seconded –

Be it enacted by the Sangguniang Panlalawigan in session assembled that:

SECTION 1. TITLE – This ordinance approves the implementation of the amended programs and projects to be funded by the share of the Province from the FY 2017 Collection of Burley and Native Tobacco Excise Tax under RA 8240 as amended by RA 10351;

SECTION 2. – The following amended programs and projects shall be charged from the Province's share in Tobacco Excise Tax for FY 2019 General Appropriations Act (RA 11260) Continuing Appropriations, to wit:

1. Construction of 2 Units warehouse (31 m x 18 m) with office (40 sq. m.) and Multi-Purpose Drying Pavement (1,200 sq. m.) – P25,000,000.00 Provincial Nursery, Sta. Barbara, Pangasinan	
2. Construction of concrete road (L=200 m) with RCBC (1-unit, 3m x 8m x 1.5m) Sta. Barbara, Pangasinan	3,500,000.00
3. Construction of 2 Units Curing Barn with Office and Multi-Purpose Drying Pavement in Villasis and Alcala, Pangasinan	10,000,000.00
4. Provision of 2 in 1 Knapsack Rechargeable Mechanical Sprayer	4,332,000.00
5. Provision of Pump and Engine Set	2,100,000.00
6. Farm Mechanization – Provision of Hand Tractor	<u>10,799,891.00</u>
Total	P55,731,891.00

SECTION 3. – The Province hereby approves the implementation of the proposed projects which fund shall be credited to the Special Account under the General Fund of the Province maintained at the Land Bank of the Philippines.

SECTION 4. REPEALING CLAUSE – All provisions of local ordinances, orders, and resolutions inconsistent herewith are hereby repealed and/or modified accordingly.

SECTION 5. EFFECTIVITY – This Ordinance shall take effect upon approval.
