**APPROVING SB RESOLUTION NO. 53, S-2018 OF THE SANGGUNIANG BAYAN OF BANI, PANGASINAN, ENTITLED “APPROVING THE ANNUAL INVESTMENT PROGRAM OF BANI, PANGASINAN FOR CALENDAR YEAR 2019 FUNDED BY THE GENERAL FUND AND 20% MUNICIPAL DEVELOPMENT FUND (MDF)”**

**WHEREAS**, the Sangguniang Bayan of Bani, Pangasinan submitted its SB Resolution No. 53, Series of 2018 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Local Development Council of Bani, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for CY 2019. This was endorsed by the Council to the Sangguniang Bayan thru MDC Resolution No. 2018-06 dated August 8, 2018 and was favorably acted upon by the Sangguniang Bayan on October 1, 2018 thru SB Resolution No. 53, S-2018;
