APPROVING RESOLUTION NO. 2022-430, SERIES OF 2022 OF THE SANGGUNIANG BAYAN STA. BARBARA, PANGASINAN, ENTITLED "RESOLUTION APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM NO. 1 OF THE MUNICIPAL GOVERNMENT OF STA. BARBARA, PANGASINAN, FOR CALENDAR YEAR 2022, REQUIRING A TOTAL FUNDING OF SEVENTY ONE MILLION, TWENTY TWO THOUSAND EIGHT HUNDRED SEVENTY NINE PESOS (P71,022,897.00)"

**WHEREAS**, the Sangguniang Bayan of Sta. Barbara, Pangasinan submitted its Resolution No. 2022-430 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the Local Development Council of Sta. Barbara, Pangasinan prepared the Supplemental Annual Investment Program (SAIP) No. 1, CY 2022 which was endorsed through MDC Resolution No. 01, Series of 2022 dated January 10, 2022;

WHEREAS, subject Supplemental Investment Program has a total investment requirement of P71,022,897.00, covers fund augmentation of infrastructure and other development projects of the LGU;
