RESOLUTION NO. 26-2020

APPROVING RESOLUTION NO. 2019-189 OF THE SANGGUNIANG BAYAN OF MANGALDAN, PANGASINAN, ENTITLED “APPROVING AND ADOPTING THE ANNUAL INVESTMENT PROGRAM (AIP) CY 2020 OF THE MUNICIPALITY OF MANGALDAN, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Mangaldan, Pangasinan submitted its Resolution No. 2019-189 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the same is in consonance to Sections 106, 109, 114 of RA 7160. The Municipal Development Council of Mangaldan, Pangasinan had identified and prioritized programs and projects in their Annual Investment Program for CY 2020. This was endorsed by the Council to the Sangguniang Bayan thru MDC Resolution No. 5, S-2019 dated October 14, 2019 and was favorably acted upon by the Sangguniang Bayan on October 25, 2019 thru SB Resolution No. 2019-189;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Mangaldan, Pangasinan was prepared using the prescribed AIP Summary Form, and covers: a) all the regular budgetary requirements for the operation of the different offices broken down into: Personal
