### RESOLUTION NO. 260-2022

**DECLARING ORDINANCE NO. 1, S-2022 OF THE SANGGUNIANG BAYAN OF SAN FABIAN, PANGASINAN, ENTITLED "AN ORDINANCE APPROVING AND RATIFYING THE LOAN CONTRACT ENTERED INTO BY AND BETWEEN THE MUNICIPAL GOVERNMENT OF SAN FABIAN, PANGASINAN AND LAND BANK OF THE PHILIPPINES FOR THE CONSTRUCTION OF THE SAN FABIAN COMMERCIAL TOWN COMPLEX PROJECT IN THE AMOUNT OF ONE HUNDRED TEN MILLION PESOS (P110,000,000.00)" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of San Fabian, Pangasinan submitted its Ordinance No. 1, S-2022 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Legal Officer, Provincial Planning and Development Coordinator and Provincial Accountant have conducted initial review and study on said municipal ordinance and found out that the same was enacted pursuant to Sections 22 (a) (5) (c), 296 (a) and (b), 297 (a) (b) and (c) and 444 (b) (vi) of R.A. No. 7160;

**WHEREAS**, the proposed project to be funded by the LBP Loan shall be included in the LGU's Annual/Supplemental Investment Program once the loan is approved;


