PROVINCIAL ORDINANCE NO. 265-2021

AN ORDINANCE AMENDING SECTION 6 (b) OF PROVINCIAL ORDINANCE NO. 258-2001, OTHERWISE KNOWN AS "AN ORDINANCE PROVIDING FOR THE OPERATION OF THE PANGASINAN MOLECULAR DIAGNOSTICS LABORATORY"

WHEREAS, Section 6 (b) of Provincial Ordinance No. 258-2001 provides for the Molecular Diagnostics Laboratory Service Fee of the Pangasinan Molecular Diagnostics Laboratory;

WHEREAS, Department of Health Circular No. 2021-0374, dated August 26, 2021, provides for the price cap for COVID-19 Reverse Transcription-Polymerase Reaction (RT-PCR) Testing;

WHEREAS, there is a need therefore, to amend Provincial Ordinance No. 258-2001 particularly Section 6 (b) thereof in compliance with the said circular;

NOW, THEREFORE, on motion of SP Member Jeremy Agerico B. Rosario, duly seconded, it was –

Be it ordained by the Province of Pangasinan in session assembled:

SECTION 1. Provincial Ordinance No. 258-2021, Section 6 (b) is hereby amended, and shall read as follows:

"The foregoing amounts shall be charged as service fee based on approved PHIC and DTI price regulation, including facilities that are under a public-private partnership agreement. The service fee shall have a price cap as follows:

Those under the category of Private are patients endorsed by private hospitals and walk-in clients who wish to avail of the services for employment, travel or other lawful purposes. Those endorsed by public hospitals, government agencies and public offices and LGUs are under the category of Public."

SECTION 2. Effectivity – This ordinance shall take effect after compliance with legal requirements under the Local Government Code of 1991.
