APPROVING SB RESOLUTION NO. 179-2021 OF THE SANGGUNIANG BAYAN OF MANAOAG, PANGASINAN, ENTITLED “APPROVING THE 3RD SUPPLEMENTAL INVESTMENT PROGRAM FOR CALENDAR YEAR 2021 OF THE MUNICIPALITY OF MANAOAG, PANGASINAN”

WHEREAS, the Sangguniang Bayan of Manaoag, Pangasinan submitted its SB Resolution No. 179-2021 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of Republic Act No.7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Provincial Planning and Development Officer have conducted initial review and study on said SB Resolution and found out that the Municipal Development Council of Manaoag, Pangasinan prepared the municipality’s 3rd Supplemental Investment Program for CY 2021 which was endorsed to the Sangguniang Bayan through MDC Resolution No. 03, S-02021 dated November 29, 2021;

WHEREAS, Supplemental Investment Program which has a total investment requirement of P1,220,000.00 covers the granting of Service Recognition Incentive (SRI) to qualified officials and employees of the LGU;

WHEREAS, funding support for the implementation of the same in the amount of P1,220,000.00 is embodied in their Supplemental Budget No. 3, FY 2021, which was enacted by the Sangguniang Bayan on December 28, 2021 through Appropriation Ordinance No. 46, S-2021;


