DECLARING ORDINANCE NO. 02-2019 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED "AN ORDINANCE GRANTING SOCIAL PENSION TO SENIOR CITIZENS WHO ARE NOT COVERED BY R.A. 9994 AND GRANTING OF OTHER BENEFITS TO ALL REGISTERED SENIOR CITIZENS OF WHATEVER SOCIAL STATUS, RACE OR RELIGION IN THE MUNICIPALITY OF SUAL" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT

WHEREAS, the Sangguniang Bayan of Sual, Pangasinan submitted its Ordinance No. 02-2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said resolution and found out that the same was enacted pursuant to Section 447 (a) (1), (5) (xiv) of RA 7160; and RA No. 9994, otherwise known as "Expanded Senior Citizens Act of 2010";

WHEREAS, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirements of posting and publication pursuant to Sections 59 (c) and 511(a) of RA 7160;
