**DECLARING ORDINANCE NO. 03-2019 OF THE SANGGUNIANG BAYAN OF SUAL, PANGASINAN, ENTITLED "AN ORDINANCE INSTITUTIONALIZING THE MORAL RECOVERY PROGRAM (MRP) IN THE MUNICIPALITY OF SUAL, PANGASINAN" AS WITHIN THE CONFERRED POWERS OF THE SANGGUNIANG BAYAN TO ENACT**

**WHEREAS**, the Sangguniang Bayan of Sual, Pangasinan submitted its Ordinance No. 03-2019 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Legal Officer, have conducted initial review and study on said ordinance and found out that the same was enacted pursuant to Section 16 of RA 7160; Article II Section 21 of the Philippine Constitution; Proclamation No. 62, dated September 30, 1992; and Executive Order No. 319 (Institutionalizing the Moral Recovery Program in all Government Departments, Offices, Agencies and Government Owned and Controlled Corporations Through the Establishment of Integrity Circles);

**WHEREAS**, subject ordinance shall take effect after the Sangguniang Bayan has complied with the requirements of posting pursuant to Sections 59 of RA 7160;
