#### **RESOLUTION NO. 270-2022**

DECLARING THE ANNUAL BUDGET FOR CALENDAR YEAR 2022 OF LINGAYEN, PANGASINAN INVOLVING A TOTAL APPROPRIATION OF P427,499,436.00, OPERATIVE IN ITS ENTIRETY

**WHEREAS,** pursuant to Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the Sangguniang Panlalawigan of Pangasinan as a legislative body of the Province is empowered to review ordinances authorizing annual or supplemental appropriations of component cities and municipalities in the manner prescribed by law;

WHEREAS, the Sangguniang Bayan of Lingayen, Pangasinan submitted its Annual Budget for Calendar Year 2022 involving total appropriations of P427,499,436.00, which was enacted on December 13, 2021 through Appropriation Ordinance No. 4, Series of 2021;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan with the technical assistance of the Local Finance Committee of the Province pursuant to Section 316 of the Local Government Code of 1991, have conducted preliminary review and study on said budget with the following findings:

1. That the appropriations for the implementation of the Third Tranche compensation adjustment shall be subject to the provisions of Republic Act No. 11466 and specific guidelines to be issued by the Department of Budget and Management. Therefore, the salary of Mr. Arnulfo S. Bernardo, Assistant Market Supervisor shall be adjusted from SG-22/2 P757,392.00 per annum to SG-22/2 P767,112.00 and Mr. Paul T. Vargas, Mechanic III from SG-9/1 P219,672.00 per annum to SG-9/1 P220,344.00 per annum;

- 2. That the projects funded under the 20% of the Annual Internal Revenue Allotment for development projects (20% Development Fund) shall be subject to the provisions of DILG and DBM JMC No. 2017-1 dated February 22, 2017 re "Updated Guidelines on the Appropriation and Utilization of the twenty percent (20%) of the Annual Internal Revenue Allotment for Development Projects' and DILG Memorandum Circular No. 2010-138 dated December 2, 2010, entitled "Use of the 20% Component of the Annual Internal Revenue Allotment Shares";
- 3. That the items funded out of the Local Disaster Risk Reduction and Management Fund shall be in accordance with R.A No. 10121 known as the as the Philippine Disaster Risk Reduction and Management Act of 2010 and its IRR, and the Department of Budget and Management -National Disaster Risk Reduction and Management Council -Department of the Interior and Local Government (DILG) Joint Memorandum Circular No. 2013-1 dated March 25, 2013 re Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund (LDRRMF);
- That all procurements to be undertaken shall be subject to the pertinent provisions of R.A. No. 9184 (The Government Procurement Reform Act) and its IRR;
- 5. That the programs, projects and activities shall be in accordance with the approved LDP and the Fiscal Year 2022 Annual Investment Program of the municipality formulated pursuant to DILG-DBM-DOF Joint Memo Circular No. 1 Series of 2007 dated March 8, 2007;
- 6. That the appropriation for Performance-Based Bonus to all qualified officials and employees of the municipality shall be subject to the provisions of IATF Memorandum Circular No. 2021-1 dated June 3, 2021;
- That the grant of step increment to some municipal employees and officials shall be in accordance with the CSC-DBM Joint Memorandum No. 1, S-2012 dated September 3, 2012 and CSC-DBM Joint Circular No. 01, S-2016 dated January 27, 2016;
- 8. That the appropriation for devolved functions and services in FY 2022 shall be in accordance with the provisions of Executive Order No. 138 dated June 1, 2021 and DILG-DBM Joint Memorandum Circular No. 2021-1 dated August 11, 2021 and shall be consistent with the Devolution Transition Plan of the municipality;

- 9. That the excess appropriation for personal services shall be subject to the provisions of Section 325 (a) R.A. 7160; and
  - 10. That the ordinance creating the various positions under the different offices shall be submitted enumerating the qualifications, duties and responsibilities of said positions.

WHEREAS, the Sangguniang Panlalawigan after final evaluation, finds the same in order provided that the findings shall be complied with by the municipality;

**WHEREFORE**, in view of the foregoing, on motion of SP Members Nestor D. Reyes and Von Mark R. Mendoza and co-sponsored by SP Members Sheila Marie S. Perez-Galicia, Jerome Vic O. Espino and Jeanne Jinky C. Zaplan, duly seconded, it was –

**RESOLVED**, as it is hereby resolved, by the Sangguniang Panlalawigan in session assembled, to declare Operative in its Entirety the Annual Budget for Calendar Year 2022 of Lingayen, Pangasinan;
