#### **RESOLUTION NO. 271-2021**

APPROVING RESOLUTION NO. 151-2020 OF THE SANGGUNIANG BAYAN OF ROSALES, PANGASINAN, ENTTITLED "APPROVING THE ANNUAL INVESTMENT PROGRAM, CALENDAR YEAR 2021 OF THE MUNICIPALITY OF ROSALES, PANGASINAN"

**WHEREAS**, the Sangguniang Bayan of Rosales, Pangasinan submitted its Resolution No. 151-2020 to the Sangguniang Panlalawigan for review and evaluation pursuant to Section 56 of R.A. No. 7160, otherwise known as the Local Government Code of 1991;

WHEREAS, the Committee on Laws and Ordinances of the Sangguniang Panlalawigan, with the technical assistance of the Provincial Planning and Development Officer, have conducted initial review and study on said resolution and found out that the Local Development Council of Rosales, Pangasinan has formulated the municipality's Annual Investment Program for Calendar Year 2021, and endorsed through MDC Resolution No. 1002, S-2020 and 1002-A, S-2020, both dated October 2, 2020 to the Sangguniang Bayan for approval. This is in pursuance to Sections 106, 109 and 114 of RA 7160;

WHEREAS, the Annual Investment Program of the municipality is in accordance with the Budget Operations Manual (BOM) for Local Government Units, 2016 Edition and in pursuance to DILG-NEDA-DBM-DOF Joint Memorandum Circular (JMC) No. 1, S-2007 dated March 8, 2007 and DBM-CCC-DILG JMC No. 2014-01 dated August 7, 2014, as amended by DBM-CCC-DILG JMC No. 2015-01 dated July 23, 2015 as to format and content. The AIP of Rosales, Pangasinan was formulated following the prescribed AIP Summary Form categorized into general public, social, economic and other services sectors and covers a) all the regular budgetary requirements for the operations of the different municipal offices broken down into: Personal Services (PS), Maintenance and Other Operating Expenses (MOOE) and Capital Outlay, b) the priority

development programs/projects of the LGU including those to be funded by the 20% development fund, and c) Disaster Risk Reduction Management Programs/Projects/Activities of the municipality. It also includes the following: 1) Gender and Development Plan, Local Climate Change Action Plan, Peace and Order Plan, Annual Cultural Development Plan, and 2) list of programs/projects/activities for Senior Citizens and Persons with Disabilities for the Protection of Children;

WHEREAS, the AIP of Rosales has a total investment requirement amounting to P247,198,282.88. The amount of P246,011,727.88 is supported by CY 2021 Annual Budget of the municipality which was enacted on December 3, 2020 by the Sangguniang Bayan through Appropriation Ordinance No. 4, S-2020 while the remaining amount of P1,186,555.00 will be funded by the Excise Tax Share of the municipality. Projects to be funded by the Excise Tax Share must be consistent with LBM No. 81 dated November 4, 2020 – "Guidelines on the Release and Utilization of the Shares of Local Government Units from the FY 2017 Collections of Excise Tax on Locally Manufacture Virginia-Type Cigarettes under RA No. 7171, and Burley and Native Tobacco Tax pursuant to RA No. 8240, as amended by RA No. 10351, chargeable against the allocations to Local Government Units under the FY 2019 General Appropriations Act, RA No. 11260";

**WHEREAS,** the development fund amounting to P36,000,000.00 which is allocated for development projects is twenty percent (20%) of the municipality's IRA (P177,422,328.00) for CY 2021. This is in accordance with Section 287 of RA 7160;

WHEREAS, the identified development programs/projects to be funded by the 20% of IRA are based on the DILG-DOF-DBM Joint Memorandum Circular No. 1, dated November 4, 2020 (Revised Guidelines on the Appropriation and Utilization of the 20% of the Annual Internal Revenue Allotment (IRA) for Development Projects); However, the municipality shall specify the details of the project, Development Assistance to Barangays;

WHEREAS, the programs, projects and activities identified to be funded by the 5% LDRRM Fund of the municipality amounting to P13,500,000.00 conforms with Section 21 of RA 10121 and NDRMMC, DBM & DILG Joint Memorandum Circular No. 2013-1 dated March 25, 2013 (Allocation and Utilization of the Local Disaster Risk Reduction and Management Fund). Further, the LDRRMF Plan of the municipality was reviewed and a certification was issued by the Office of Civil Defense (OCD) to the LGU dated November 4, 2020;

**WHEREAS**, the LGU has also identified programs, projects and activities responsive to Climate Change and tagged its corresponding expenditures in their AIP. This is in pursuance to DBM-CCC-DILG Joint Memorandum Circular No. 2015-01 dated July 23, 2015;
